
Frequently asked question for E-filling users:

## (1) Why Token email id is blank?

Follow the following steps to resolve this issue:

- Token software must be installed in your system.
- Download the latest nCode in your system.
- To verify please go to Internet explorer tools –General content certificate detail -subject alternative name – email id should be mentioned.(This has been explained below using pictures)

Open Internet Explorer and click on the gear icon.



Select Internet options.



Scroll down to the **Subject Alternative Name** option. Click on it. Check if your email id is showing or not.

If email id is showing then ensure that the email id of your token is same with EFilling account's email id.

If email id is not showing then contact your token vendor.

## (2) Error Connecting to PKI Component.

Follow the following steps to resolve this issue:

- Kindly check if PKI Component (nCode) is running or not. For detailed instruction follow point no 10 mentioned below.
- If nCode is running and still error is showing then download the latest nCode software. Follow point no 3 for the same.
- If you have already downloaded the latest nCode and the error persists then contact us at <u>ccls@concorindia.com</u>

• Click on PKI Component Setup. Extract the zip file, and install latest nCode software in your PC .

## (4) Problem with extracting downloaded nCode software.

If you face any issue with extracting the PKI32.zip (nCode software) file. Kindly download the WinRAR software from <a href="https://www.win-rar.com/start.html?&L=0">https://www.win-rar.com/start.html?&L=0</a>

After downloading the WinRAR try to extract the zip file.

### (5) What is the process for new e-filing registration?

For the new e-filing registration party must be registered in the CCLS commercial system along with party type. PAN no. is mandatory against each party code.

For example:

Example Party type	Example party code
Exporter	E4531
Importer	11234
Forwarder	F1234
CHA	C1234

## (6) What facilities are available against OTP and PKI(E-filling User mode)?

There are two different modes through which E-filing can be accessed

**OTP** – User will log in through OTP received on their registered mobile number.

With the OTP facility, user can download the invoices, queries, and PDA statement related facilities.

**PKI** (Parties having digital token) – All parties having a digital token should register with the PKI facility. PKI facility user must install their digital token software and the token must be attached to the PC. The email id of the digital token should match with the e-filing user email id.

Facility with PKI component – EJO/LJO, seal cutting, gate pass, LCL carting, Export carting (For CHA – Exporter) and KYCL for importer, exporter and other major facilities.

# (7)What should we do if validity of the dongle/digital certificate expires?

If the validity of dongle or digital token expires:

- Purchase new DSC (dongle/ digital certificate) from your token vendor.
- It must be ensured that the email id of the new digital token should be same as existing e-filing account email id.
- After getting new digital token, install it, in your system and it can be used with existing e-filing account.

(8) What should we do if email id is different in the new dongle or

#### This error always appears when

email id is changed in new dongle or digital token, For such cases parties have to apply for new e-filing registration with new token and new email id details.



## (10) How to Check if nCode running or not?

• Go to system taskbar at right side- bottom where date and time showing.



• Click on the **up-arrow** button.



- If Capital N with blue background icon showing in the taskbar. Then nCode software is installed successfully.
- If nCode icon not showing in taskbar then click on start/window button and search *ncode*.

• Double click on nCodePKIComponentV4.

# (11) What should we do if system is new/corrupted and want to use E-Filling?

Download the Java from our website Login Help section using "Download Java 8 Setup".

Then download PKI Component software (Refer Point 2).

After PKI Component software install successfully, ensure that nCode is running.

## (12) Invalid user credential or Forgot password

This error comes when the user enters the wrong password. Please use the Forgot password option and reset the new password. Go to <u>http://ccilweb.com/CCLS/forgot-password.html</u> for forgot password or reset the password.

#### PROCESS FOR GENERATION OF CRN FOR WAREHOUSE STUFFING.

PRE CONDITION : -

- (1) Shipping bill must be online from custom to CONCOR
- (2) Exporter code must be registered in CONCOR commercial system.
- (3) IEC code of custom for shipping bill must be registered in CONCOR as exporter
- (4) Container should be available of same shipping line.
- (5) Cargo weight should be entered in quintal. For example 1000 kg will be entered 1.
- (6) Vehicle no should be entered


